- residents concerns passed on re Coastal footpath route through Aldingham. The time period for representation to the Secretary of State is now closed and no opportunity for the PC to lobby further.

- approximate costs in the region of £3k received for Aldingham Community Toilets upgrade. Options would be for the PC to make the improvements or to be done via donation to ACT. More detailed costings needed before decision. To re-agenda.

Sea defenses work still to happen. Ramp & Access point at Newbiggin - Cllr Martin to speak to engineer at CCC.

Potholes at Baycliff reported and there are very many. To write to CCC and copy to Cllr Willis

Bin at Leythey Lane – has been approved. SLDC installation costs were £50 per hour. Emptying would be £3.65 + VAT per emptying (fortnightly). Resolved: To ask the Parish Steward to install.
