- graffiti all over the Toilets at Aldingham – Police matter. Clerk to report to PCSO Madden along with drug use.
- bin @ Leythey Lane – installed and operational. Being very well used. Requires emptying more often. Agreement to increase emptying to weekly for 6 months
- Gleaston – residents making good use of HIMS system.
