To comment on current planning applications and planning issues SL/2021/0638 – Rosedene, Leythey Lane, Baycliff - Extension of dwelling footprint and raising of roof to provide 1st floor living accommodation & erection of a storage shed. Disproportionate elevation/scale. Resolved: Response of objection based on scale and possible loss of privacy/overshadowing.

SL/2021/ 0809 - Driftwood Cottage/Rabbit Run, Leythey Lane, Baycliff - not an active planning application yet.
