- Baycliff play area wall has been repaired but the rebuild appears to be poor and potentially unsafe - looking like it could easily fall down again. There is also a lot of stone left over with the wall lower than it was. Clerk to report this to the insurers. Insurers have confirmed that 3rd party liability has been accepted.
